Competition Rules and Regulations:

1. All dancing rules and regulations governed by SOBHD.
2. Decisions of the competition organizer and judges are final, including the number of placements in any event.
3. Classes will be divided according to the number of entries received. The CVHDA reserves the right to combine, cancel or divide an event.
4. Competitors must dance only in their respective age groups.
5. Age of dancer as of date of competition.
6. Competitors will compete in reverse order of entry and must be on hand when their event is called or forfeit entry in that event.
7. Competitors must dance with swords and to music provided by CVHDA.
8. No refunds unless request accompanied by doctor's note.
9. Competition organizer must be notified of any class changes by August 3, 2018. Email to: thecoogans@shaw.ca
10. Protests must be made in writing and given to the Competition Organizer at the event, accompanied by \$15.00 fee (refundable if sustained).
11. All competitors must be in full costume and present current ScotDance Registration card to receive their medals. A \$5.00 administration fee is charged for forgotten cards.
12. Marshals and Competitors only in marshalling area.
13. **Cheques payable to CVHDA. No post-dated cheques please.** NSF cheques will be charged \$25.
14. This competition is closed – residents of Vancouver Island only.
15. **Entries must be received by Friday, August 3, 2018. No late entries accepted.**
